

Based on the Articles 30 and 32 of the Law on Prevention of Money Laundering and Terrorist Financing (hereinafter: the Law, "Official Gazette CG", No. 33/2014 and 44/2018, 73/2019 and 70/2021), the payment institution is obliged to determine whether the client is a politically exposed person.

FORM FOR IDENTIFICATION OF A POLITICALLY EXPOSED PERSON

Politically exposed person, in terms of Law, is considered to be an individual performing a prominent public function in the country, foreign country or an international organization, as well as such individual for the period of at least 12 months from the termination of performing public function, including close family members and close associates of those individuals. **Close family members of politically exposed person** are considered to be martial or extramarital spouse and children born in marriage or out of marriage and adoptees, their martial or extramarital spouses, parents, brothers and sisters. **Close associates of politically exposed person** are considered to be an individual who have joint profits from property or established business relationship or other form of close business contacts with them.
